GAZETTE NOTICE

In accordance with section 5 (3) and section 7(2) of the Health Practice Law (2017 Revision), the following fees will be charged for the Health Care Facility Registration and Inspection

Health Care Facility Fees

The fees are in Cayman Islands Dollars (KYD), and are as follow:

New Application:

- Initial Application Fee - \$300.00
- Inspection and Facility Fee - for a facility with up to 3 beds, chairs, and /or clinical / examination rooms - \$1,000.00 per annum.
- Inspection and Facility Fee for a facility with more than 3 beds, chairs and /or clinical /examination rooms - fee of \$1,000 plus \$200.00 per bed, chair, and/or clinical/examination room per annum.

Renewal of Application with Inspection

- Inspection and Facility Fee - for a facility with up to 3 beds, chairs, and /or clinical / examination rooms - \$1,000.00 per annum.
- Inspection and Facility Fee for a facility with more than 3 beds, chairs and /or clinical /examination rooms - fee of \$1,000 plus \$200.00 per bed, chair, and/or clinical/examination room per annum.

Renewal of Application without Inspection (where the HPC has approved registration for more than 1 year)

- Application Fee for Renewal of Certificate (**no inspection required**) - for a facility with up to 3 beds, chairs, and /or clinical / examination rooms - \$750.00 per annum.
- Application Fee for Renewal of Certificate (**no inspection required**) - for a facility with more than 3 beds, chairs, and /or clinical /examination rooms - fee of \$750.00 per annum plus \$200 per bed, chair and /or clinical /examination room per annum.

Application for an amendment to registration as a Health Care Facility

- \$100.00 Administrative Fee
- \$500.00 Inspection Fee

Late Filing Fee for the Renewal of Certification of Operation

- \$400.00

Follow-Up Inspection Fee -Non Compliance

- \$500.00 per visit

All relevant fees will be due upon receipt of application

- Annual fees are due on the renewal of application plus the fee for the number of beds, chairs and /or clinical /examination rooms.
- The follow-up inspection fee will be applied whenever an inspection for non-compliance is required.

PLEASE NOTE THAT WHERE A HEALTH CARE FACILITY IS GRANTED CERTIFICATION FOR MORE THAN ONE YEAR BY THE HEALTH PRACTICE COMMISSION, THAT HEALTH CARE FACILITY WILL BE REQUIRED TO PAY THE ANNUAL RENEWAL FEE FOR THE CERTIFICATE TO OPERATE THE HEALTH CARE FACILITY. THE FEE CAN BE PAID IN FULL AS A LUMP SUM OR PAID ANNUALLY ON THE RENEWAL DATE OF THE CERTIFICATE. FAILURE TO PAY THE REQUIRED FEES WILL RESULT IN THE REFERRAL OF THE MATTER TO THE ATTORNEY GENERAL'S CHAMBERS FOR ACTION
